

# Regulations Governing On-campus Medical Visits for Faculty, Staff and Students at National Taiwan Normal University

Approved at the 1<sup>st</sup> Meeting of Administrative Officers in 2014-2015 academic year on September 17, 2014

1. Students, faculty, staff and their dependents, and retirees of National Taiwan Normal University (the “University”) shall be given a discount on the registration fee of medical visits when they register with their National Health Insurance Card and present one of the following credentials in accordance with the agreement between the University and its partner clinics.
  - (1) Student ID of the University.
  - (2) Faculty or staff service ID of the University.
  - (3) Retiree ID of the University.
2. Students of the University who are children of low-income, low-middle-income families or families in hardship shall be entitled to subsidies, i.e., registration and copayment fees, for 10 on-campus clinic visits per year as a means of looking after disadvantaged students. The costs of these visits are supported by the student public funds and incentive funds of the University (see notes).
  - (1) National Health Insurance Card
  - (2) Student ID of the University

\*Note 1: Items of self-payment, e.g., medication or examinations not covered by the National Health Insurance and certificate of diagnosis, as well as medical expenses incurred due to the following reasons are not covered by the subsidy.

  - (1) Intentional acts of the insured person (including attempted suicide).
  - (2) Illegal use or administration of narcotic drugs by the insured person.
  - (3) Outpatient surgery, outpatient cosmetic surgery, plastic surgery not intended for therapeutic purposes or surgeries for congenital deformities, dental care or eyes, or eyeglasses, hearing aids or other accessories.
  - (4) Health checkups, recuperation or convalescence.

\*Note 2: The insured may not make repetitive application with the Student Accident Insurance and the scope not covered by the Student Accident Insurance is also not within the scope of this subsidy. For non-illness outpatient services due to accidental injuries, e.g., car accidents or sports injuries, the insurance claim shall be made following the procedures stipulated in the Student Accident Insurance.

\*Note 3: Students of the University who meet the criteria for low-income, low-middle-income families or families in hardship and do not have National Health Insurance coverage are eligible to receive subsidies for outpatient visits on campus at their own expense with their student ID card; the maximum subsidy is capped at NT\$500 per visit and up to NT\$2000 each year.

3. Foreign students, e.g., students at Mandarin Training Center, shall be assisted by relevant responsible units to make medical visits and be responsible for their own medical expenses.
4. The medical bills arising from the situations stated in Article 2 herein shall be submitted to the University by the partner clinics for reimbursement on the basis of receipts and patient list.
5. The Regulations and any amendments thereto shall become effective after approval by the Meeting of Administrative Officers and ratification by the University President.
