National Taiwan Normal University Guidelines for Emergency Injury and Illness Management

Approved at the 307th and 308th Administrative Committee on December 7, 2005 Approved at the Meeting of Administrative Officers in 2016-2017 academic year on September 21, 2016

1. Legal Basis

(1) Provisions in Paragraph 1, Article 15 of the School Health Act.

(2) Provision in Regulations Governing the Handling of Injury or Illness by Educational Institutions under Ministry of Education Jurisdiction.

2. Purpose

To enable the various units of the University to jointly handle emergencies promptly to ensure the safety of faculty, staff and students.

3. Implementation Method

- (1) Management procedure
 - a. In the event of an accident, parties present at the scene shall immediately take the injured person to the Health Center or call medical professionals to the scene to administer first aid. If the injured person is unconsciousness, has broken bones, difficulties in breathing, or is bleeding profusely, call 119 for medical support first and notify the University's medical staff to go to the scene to administer first aid.
 - b. If the injury is minor, the injured person shall be treated on the spot or be taken to the Health Center for treatment.
 - c. If the injured person needs to be taken to a hospital, the nursing or relevant staff shall accompany them to the hospital and notify their parents or concerned parties.
 - d. The accompanying staff member shall inform the Health Center of the condition of the injured person.
 - (2) The management procedure is shown in detail in the flow chart below.
- 4. Reporting
 - (1) The Student Adviser Office shall report to the Ministry of Education according to the campus safety management system.
 - (2) Cases of infectious diseases or food poisoning shall be reported to the health authorities by the Health Center.
 - (3) In the event of a major occupational disaster, the University's Environmental and Public Safety Center shall be notified immediately to report to the competent labor inspection agency in accordance with the Occupational Safety and Health Act.
- 5. The Guidelines and any amendments thereto shall become effective after approval by the Meeting of Administrative Officers.
