

# National Taiwan Normal University Regulations for the Establishment of the University Health Committee

Article 1 The Regulations for the Establishment of the University Health Committee are enacted pursuant to Paragraph 10, Article 14 of the University Charter.

Article 2 The University Health Committee (the “Committee”) is established for the purpose of promoting school health and improving the physical and mental health of faculty, staff and students.

Article 3 The tasks of this Committee are as follows.

1. To review, supervise and evaluate the University’s health work plans.
2. To promote health care services for the faculty and staff.
3. To provide health education and health counseling in the University.
4. To oversee and improve the University’s environmental health.
5. To handle other health related matters at the University.

Article 4 The Committee shall have one chairperson, to be served by the Vice President for Student Affairs, and several Committee members appointed by the Vice President for Student Affairs. The members shall comprise of the Vice President for Academic Affairs, Vice President for General Affairs, Chair of Department of Health Promotion and Health Education, Director of Athletic Department, Director of Health Center, Director of Student Counseling Center, Director of Student Adviser Office, Director of Environmental and Public Safety Center, Director of Campus student housing, Head of General Services Division, Head of Academy of Preparatory Programs for Overseas Chinese Students-formerly for Student Affairs, the three representatives appointed by the student council, Head of

Division of Student Affairs at Gongguan Campus, Chief of Heping Campus Student Dormitory Committee, Chief of Gongguan Campus Student Dormitory Committee. One to two external experts or scholars may be invited to attend. There shall be one Executive Secretary, to be served by Director of the Health Center. All above members shall be appointed for a one-year term and serve without compensation. However, external members may be compensated with an honorarium in accordance with regulations.

Article 5 The Committee shall meet at least once every academic year, and an extraordinary meeting may be convened when necessary.

Article 6 When the Committee is in session, it shall be chaired by the chairperson. If the chairperson is unable to chair the meeting, the chairperson shall designate one Committee member as the substitute chairperson.

Article 7 The resolutions decided by this Committee shall be respectively passed to relevant units of the University for implementation.

Article 8 This Committee may cooperate with the University's Student Food Safety Committee and Environmental and Public Safety Center to jointly promote various initiatives.

Article 9 These Regulations and any amendments thereto shall become effective after approval by the Administrative Council.
